Bedford County was formed in 1753 from Lunenburg County. Part of Albemarle was added in 1754 and part of Lunenburg was added later.

Scope and Content

Bedford County (Va.) Records, 1772-1800. Consists of two judgments, *Burton v. Haynes*, ca. 1797; and *Evans v. Frederick*, ca. 1799; the estate account of Richard Dearen, 1772; and a petition and report, 1800, pertaining to a proposed road from Davies' Ferry Road at the upper end of Philip Burton's plantation to the county line.
