Historical Information

Prince William County was formed from Stafford and King George Counties by a statute adopted in 1730, to take effect on 12 March 1731. The county was named for William Augustus, duke of Cumberland and third son of King George II.

Many pre-Civil War records were lost, destroyed, or stolen by Union troops in 1863 during the Civil War. Sixteen deed books and five will books are missing.

The records in this volume were originally created by the County Court.

Scope and Content

Prince William County (Va.) Bond Book, 1753-1786. Bonds are obligations or covenants between persons, made binding by a money guarantee. Bonds are given for various causes, and show the names of the principal and sureties, the date, amount and condition of the obligation, and signatures.
