Within the land acquisition papers is included a deed (October 18, 1816) and a copy of a historical preservation report written by Dr. George Green Shackelford on the Michael Kinzer house. The wallet included in the collection was a Christmas present to W. A. Bell from W. B. Fiser in 1898.
