This collection consists of an inventory of the estate of William Deal, of Patrick County, Virginia. Completed in September, 1808, the inventory is signed by David Taylor, John W. James, and John James. The inventory lists the values of various household goods, including furniture, bedding, and cookware; and farming equipment, including tools and horse tack.
