Biographical Information

The document mentions a suit brought by Dr. E. M. Campbell against Edward E. Lathim, both of Washington County, Virginia. The suit concerns payment due for a post-mortem examination of Jessee, an enslaved person, said to be killed near Bristol, but without further identifying information.

Scope and Content

The collection consists of a Court Document, May 28, 1860, Washington County, Virginia, signed by John S. Kreger, likely a Court Clerk. This document orders Edward E. Lathim to pay E. M. Campbell \$20.00 for a post-mortem examination of Jessee, a person enslaved by Lathim, said to be killed near Bristol.
