[Writes in regard to a legal dispute re the survey, purchase, sale, and previous ownership of 300 acres of land, to be heard in Carlisle Court (Carlisle, Pennsylvania). Contends that a Captain Sharpe is due payment from John Immeland Paul Immel, and reviews the history of the tract and his own involvement. Persons mentioned include Frederick Stuber, Mr. Magaw, Mr. Hoops and his heirs, Colonel Armstrong, and Mr. Wilson.]
