Heading on document, "Gesellschafts Vertrag" which translates to "Social Contract," a partnership agreement. Relates to the sale or purchase of nearly 2 million acres of land in Virginia and Kentucky, as well as additional land near Boston, Massachusetts. Includes 4 wax seals. Written in German. 7 pages.
