- 2) Confederate bond issued to James M. Beckham for the amount of \$500, assigned to J.R. Ervin of Bath County, Virginia (1864)
- 3) financial agreement between Jonathan Jackson, father of "Stonewall" Jackson, and Peter Eile, both of Harrison County, for payment of three dollars and sixteen cents with interest (1821)
