**Processing Information**

This collection was originally two accessions, one in 1955 and one in 1956. The second accession was briefly A&M 913. Processing efforts throughout the years have gradually merged the two together, but some elements of the original separation remain. Boxes 1-48 were part of the original accession, and boxes 49-76 (accessioned as 1-28) for the second. As part of the most recent reprocessing efforts in March 2026, boxes 67-76 were renumbered so that box numbering was sequential (they had been relabeled as boxes 78-87, and the skipped numbers were used for some of the wrapped packages). Assistance can be provided for researchers needing to match old box numbers to new box numbers.

This collection is minimally processed; materials are stored mostly as they arrived: in their original envelopes, or loose in boxes, and so that records produced for the same reason are generally together. Records have not been chronologized or alphabetized, and there is no indexing for the collection.

## Index

This collection has not been indexed. A rough, itemized list of the materials in box 76 and packages 1-3 include minimal information on the date, and type of record, but the list does not provide exact locations and may not be inclusive. This inventory, and another, are located in the control folder for this collection.

## Arrangement

The collection was loosely arranged into topical series for each accession, so that the first accession contained four series (court records, public records, county financial records, and county health records), and the second accession had seven series (court, tax statements, road funds, DPA [Department of Public Assistance?] records, blank forms, box 75, and county financial records). The materials remain loosely grouped in these topical categories.

Some of the materials are grouped together by case, and have a note about record type (deeds, marriage licenses, etc.), persons involved, or the year on the envelope, or on a paper attached to the records.

### **Scope and Contents**

Series 1- Microfilm, consists of 157 reels of microfilm. Reels 1-9 contain materials from boxes 1, 14-16, 26-30, and 44, primarily marriage, land, and bond records. The remaining reels are of various records relating to court proceedings, including execution, fee, and rule books as well as dockets (both civil and criminal). Other record books include vital records (marriage, birth, and death), taxation (land and property), and deeds. There are also a small number of records of railway and lumber companies, and a record of World War I enlisted men and officers of Braxton County.

## **Scope and Contents**

Series 2- Original Materials, consists of 76 boxes of various records, and 18 "wrapped packages." The boxed material consists of various court and public records, primarily relating to court cases, financial records, and marriage records. Court cases include a variety of cases, including estate and chancery cases, as well as financial matters, working conditions, and liquor. Many of the cases include extensive and detailed transcripts of court proceedings and witness statements. Packages 1-7 are sets of envelopes or folders wrapped in paper, not bound volumes. Packages 4-7 are shorthand notes for various cases, sometimes including additional materials relating to the case such as newspaper articles and other papers. The notes are collected in folders which are labeled with the case and arranged alphabetically. In addition to the estate cases, there are also some deeds (boxes 27-28) and various bills of sale, contracts, estrays, etc. Financial records include tax records, road funds, sheriff's expenses, and financial records of the Public Health Service and the department of Public Administration County Relief Records. These records are mainly related to the expenses of administration and staff. This series also includes poll books and election returns from 1836-1860, and tally sheets, nomination certificates, lists of voters, and election results for

1936.

Boxes 45 and 75 contain correspondence to C.H. Bland, clerk, and Earl W. Underwood, sheriff. Correspondence to Underwood is primarily related to tax returns. Bland's includes court related business as well as personal papers related to the Standard Home Company fraud case in Birmingham, his Free Masons membership card, and other financial matters. Box 66, Tax Receipts, are also in envelopes addressed primarily to Underwood. Records are in their original envelopes. Box 74 contains blank forms for various county records including; tax documents (circa 1923-1951), absentee ballot applications, employee compensation, court summons, case envelopes, and other assorted records, none of which have been filled out. There is also a blank parole form attached to a letter from the warden in box 72.

Highlights for this series include roughly 3,600 records of State Health examinations performed by the Division of Child Hygiene from 1936-1943 (boxes 46-48). These records can provide statistical information on the health, history, and living conditions of children in Braxton County such as height, weight, history of disease, how long they were bottle or breast fed, parents' occupations, and brief notes about home life. These records are restricted for general use, but access may be requested for their use in research. Many of the court cases for Braxton county include extensive transcripts and witness statements, which provide detailed accounts of the court proceedings (predominantly boxes 49-57). Several of these are related to cases against companies including the Elk Lead Zinc Company (1906, Box 53); the Pittsburgh Railway Company (1896, Box 50); and the Novelty Mill Company (1894, box 49). The cases in box 52 include extensive details of a case concerning sale of liquor and a doctor writing prescriptions for liquor (circa 1908).
