A petition signed by 324 students of Hurricane High School on May 2, 1941 protesting existing conditions in Hurricane, W.Va. (2) Stop drunkenness and disorderly conduct on our streets. (3) Cooperate with the State Police in any attempt to enforce obedience to law and order. (4) Close Sunday Theatres.'
