## Scope and Contents

These are the land and mercantile papers of Felix Hansford, a large land owner along the banks of Pain[t] Creek and the Great Kanawha River, near the town of Clifton in [Kanawha] County. The collection is primarily account statements, receipts and business notes. There are a few land surveys, entries and deeds dating back to the 1790. Some of the papers shed light on the Hansford's activities as a falt boat builder, sawmill and grist mill operator, and justice of the peace. A few letters and bank statements deal with his term as president of the Giles, Fayette and Kanawha Turnpike Company.
