Flash 2, 1883-1887, cash book, bank account and journal, separate account for R. W. Gardner and R. J. Bell. Flash 3, 1897, 1898 day book record of fines and costs for cases listed as debits, rest of book is cash book listing people almost exclusively. Flash 4, in 4 parts, journal and ledger of Brights Mill, Alderson; in addition to standard mill items, lists coal and covers periods of 1889 Jul-1891 Apr; 1892 Jul-1893 Nov; 1892 Jul-1894 Feb; 1898 Apr-1899 Oct.
